Learning outcomes of the course unit: <i>Students by completing the course will gain insight and knowledge about the role of private, public and third sector in the mixed economy, the economy, the public sector as applied scientific disciplines, which are connected to different sectors of the economy of the public sector, for example economics of defense, education, health etc. Student are to know the terms of public sector issue, the basic data and with regards to the organization and functioning of the public sector in Slovakia, also its structure and methods of measuring its size, political and economic areas in terms of public choice theory, the cause of the public sector as well as the causes of inefficiency public sector reform, and the bureaucracy. The student should understand the economics and efficiency of the public sector, the role of the management of public authorities in managing various sectors, regions and sections of the public sector and also to the role of public choice. The current state of public utilities and services, and the importance of the state budget as the most important part of public finances. After successful completion of a learning process the student should be able to do the analysis, and reporting on the share of each sector within a mixed economy, the importance and size of the public sector within the EU and the OECD, the overall condition of the individual sections, areas and sector and public sector share of public policies on the public sector. Further evaluation of reform changes aimed at eliminating inefficiencies in the public sector and in the activity of bureaucracy - official may apparatus in the public sector.</i>
