(bachelor)* **Course prerequisites:** *none* **Assesment methods:** Throughout the semester, active participation, preparation of required tasks (the presentation of an EU country in Russian language) will be assessed. There will be two written tests – 30 points each. The assessment: A -- 55 points minimum, B -- 50 points min., C -- 45 points min., D -- 40 points min. E - 35 points min. Students who fail to collect the minimum of 15 points will not be awarded the credits. At the end of the semester, during the exam period: credit test. Final assessment: average result of all grades achieved. Learning outcomes of the course unit: The course will enable students to gain both general and specialized foreign language knowledge

in accordance with their study programme through developing skills in writing, reading, listening and specialized communication. Student will be able to communicate in Russian, both in written and oral forms, about basic issues occurring in the area of social and economic relations. After having successfully completed the learning process, the students will be able to use specialized foreign language skills when discussing given topics. Students are expected to be ready to continue in the Russian language learning in the follow-up university study.

1. Labour market. Basic terms associated with employment and labour market. Word anatomy. Past tense and present tense of the noun "sapozhnik i portnoi".

2. Unemployment. Types of unemployment.

3. Role of Labour Office. Trade Unions.

4. Public Administration in the Slovak Republic. System and organization. The basic conceptual system.

5. History of public administration in the Slovak Republic. Reforms. Etymology of words.

6. The bodies representing legislative, judicial and executive power in the state.

7. State administration. Basic terminology.

8. Self-government. Structure. Basic terminology. Competencies.

9. Self-governing regions. Basic terminology, competencies.

10. Towns and municipalities. Structure. Basic terminology, competencies. The origin of the names of some Russian cities.

11. PA in selected European countries.

12. Elections. Electoral system. Terminology.

13. Final test, evaluation, analysis of the most frequently occurring errors.
