Criminal law, criminal procedure, criminal liability in health care.6. The employment law, corporate social policy and human resources, employment liability in health care.7. Administrative law and administrative procedures in health care.8. Social insurance, health insurance, work injury compensation scheme, regression and regression procedure.9. Medical and health law, modification, legislation in health care.10. The protection and development of public health, basic concepts and institutes, Health management in Slovakia.11. Health care professional and the patient, Charter of Patients' Rights in Slovakia.12. The medical procedures, catalogue, list of medical procedures, medical records, informed consent of the patient, biomedical research, transplantation, sterilization procedure during death.13. Health care, services related to health care, forms of health-care provision, professional organizations in the health care sector.
