Assessment methods: The student will acquire 50 points per semester: - Practical demonstration of skills (20 points) - Credit - written test (30 points) To achieve A, at least 48 points have to be obtained, to achieve B, at least 44 points have to be obtained, to achieve C, at least 41 points have to be obtained, to achieve D, at least 38 points have to be obtained and to achieve E, at least 35 points have to be obtained.	
Learning outcomes of the course unit: To deepen students' theoretical knowledge gained previously, in the study of particular current and applicable legislation, to familiarize them with the supporting pillars of public health, state health surveillance and health promotion and organization of work in particular fields of RÚVZ. They acquainted with documents such as reports of the performance of state health surveillance, documents of the World Health Organization aimed at eliminating infectious but also the most frequent chronic diseases.	
Course contents: 1. Work with the literature and legislation finding out about the historical development of public health, its place in the system of providing health care, competence and responsibility. 2. The use of information technology in acquiring and processing information acquired in the exercise of state surveillance and health promotion. 3. World Health Organization (WHO) - the main strategic goals, the practical use of the WHO recommendation listed on its website in English. 4. The functioning of the human body in health and disease, holistic approach to man. 5. Determination of the main areas of environmental health, positive and negative, options for addressing the negative impacts on human health. 6. A system for monitoring the health status of the population, with selected, reported indicators commonly occurring disorders. 7. The CINDI - present and future project EHEST - European population health survey, comparison of results between EU countries. 8. Nationwide health promotion and risk factors, highlighting the cooperation between professional and general public. 9. Identifying the causes of abortion, divorce - compare the various regions of Slovakia, the proposed measures. 10. Comparison of monitoring health awareness Slovak citizens and residents of the European Union. 11. The development of a specific program for the prevention of alcoholism in schools.
