Marking of the course: A – at least 92 points, B – at least 83 points, C – at least 74 points, D – at least 65 points, E – at least 56 points.</i>	
Learning outcomes of the course unit: <i>The course of Introduction to Political Science Theory is designated for freshmen political science students (1st semester). The graduate students gain basic political science terms and their characteristics, and use them in a correct theoretical concept. Students understand democracy as one of the forms of government and other concepts relating to theory of democracy. Students also understand the terminology to political party concepts and issues of elections. The part of this course is the processing of Max Weber's Politics as a Vocation in the form of presentation.</i>

Term of Political Ideology.</i> <i>10. Terms: Political Party, Class, Nationalism, Conservative Parties, Social Democratic Parties, Liberal Parties.</i> <i>11. Elections and Electoral Systems.</i> <i>12. Terms: Proportional Electoral System, Majority Electoral System, Coalition Government.</i> <i>13. Final seminar.</i>
